INTRODUCTION

This Cookie Policy explains how Obrecsys LLC. ("Kampfire", "We", "Us", or "Our") uses cookies and similar tracking technologies when you visit:

- Our websites, including but not limited to www.kampfire.online and www.obrecsys.com ("Websites")
- Our Kampfire application and related domains ("App")
- Event landing pages shared by event managers ("Landing Pages")

This policy should be read together with Our Privacy Notice, which explains how We collect and use your Personal Information.

WHAT ARE COOKIES AND SIMILAR TECHNOLOGIES?

Cookies are small text files that are stored on your device (computer, tablet, or mobile) when you visit a website. They help websites remember your preferences, understand how you use the site, and improve your experience.

Similar technologies We use include:

- **Pixels/Web Beacons** – Small invisible images embedded in web pages or emails that track whether content has been viewed.
- **Local Storage** – Data stored in your browser that persists even after you close it.
- **Session Storage** – Data stored temporarily in your browser for the duration of your session.

Consent behavior:

- **EEA/UK/Switzerland users:** Cookie banner displayed; you choose to accept or reject
- **Other regions:** Analytics enabled by default; you can opt out using browser settings

LANDING PAGES (Event Photo Sharing)

When you visit a landing page shared by an event manager to view your personalized photo album, We use local storage to provide a seamless experience.

Essential Local Storage

This storage is necessary for the landing page to function and remember your photo album access.

Storage Key	Purpose	Data Stored
Persistent State	Remember your album access so you don't need to re-verify on return visits	User ID, verification status, session identifiers
Form Submitted	Track if you've already submitted any required forms	True/false flag
Consent Preference	Remember if you declined biometric photo matching	True/false flag
Security Token	Protect your session against unauthorized access	XSRF token

How it works:

- When you verify your email or upload a selfie to receive your personalized photo album, your access is saved in your browser's local storage
- On return visits to the same landing page, your album is automatically displayed without requiring re-verification
- If you decline biometric consent, this preference is remembered so you won't be asked again
- This data is stored locally on your device and is specific to each event

Important: This local storage is essential for the landing page functionality. Without it, you would need to re-verify your identity every time you visit to access your photos.

HOW TO MANAGE COOKIES

You have several options for managing cookies:

Browser Settings

Most web browsers allow you to control cookies through their settings. You can typically:

- View what cookies are stored on your device
- Delete all or specific cookies
- Block all cookies or only third-party cookies
- Set preferences for certain websites

Please note that blocking or deleting cookies may affect your experience and some features may not function properly.

To clear your saved album access for a specific event landing page, you can:

1. Clear your browser's local storage for the landing page domain
2. Use your browser's "Clear site data" feature for the specific page

Note: Clearing this data means you will need to re-verify your identity to access your photo album.

Do Not Track

Due to lack of standardization, currently Our systems do not recognize browser "do-not-track" requests. However, you can use the methods described above to manage your preferences.
